

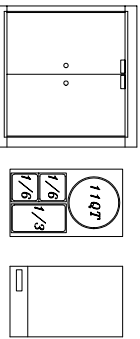

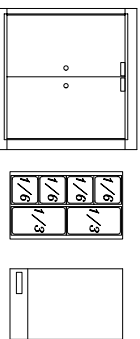

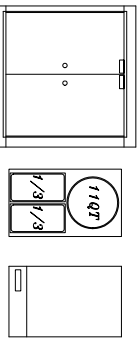
TWO DOOR OVEN, A STEAM TABLE

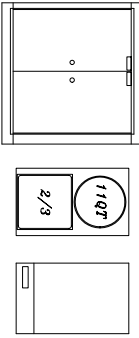
TWO DOOR OVEN, A STEAM TABLE

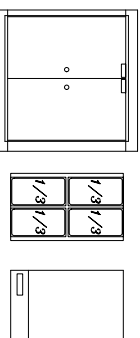
TWO DOOR OVEN, A STEAM TABLE

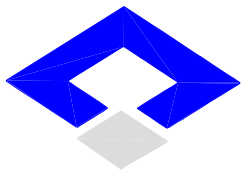


TWO DOOR OVEN, A STEAM TABLE
